

# Miller Park Pool Rental

## Pool Rules

- Patrons are asked to follow the posted pool rules
- Everyone must wear appropriate swimwear – cut off jeans are not allowed
- Only US Coast Guard approved life jackets are allowed in the water. We have a limited number of lifejackets available for use upon request. Floats, rafts, boards, and inner tubes are not allowed.
- No animals or pets except for certified special needs animals
- No glass items

Miller Park Pool is a drug free & tobacco free facility. Patrons may be expelled from the pool & park complex for fighting, use of illegal substances, and alcoholic consumption. It is illegal to possess or consume alcoholic beverages within Lynchburg City Parks!

## Rules for Rental Groups

- A minimum of 1 adult chaperone must be provided for every 10 children
- Group may not use the rental as a fundraiser and cannot charge admission
- Group must provide an adult gatekeeper to ensure that all Covid-19 precautions (includes taking temperatures of attendees, asking the required Covid-19 questions, & having waivers signed) are taken and enforced and that only members of the scheduled party or group are admitted
- The pool staff may begin to clear the pool and swim area 15 minutes prior to the scheduled end of the rental to help ensure that the rental time is not exceeded
- Only food, drinks, and coolers that are previously arranged with the consent of a Parks & Recreation Aquatics Supervisor will be permitted.
- The amplification of music, speeches, or any other sound audible beyond 25' is prohibited except upon written permission from the Director of Parks & Recreation.

## Inclement Weather Policy

- Inclement weather may impact patron safety in and near the water. Lynchburg Parks & Recreation reserves the right to stop pool use before, during, and after threatening weather conditions.
- In the event of inclement weather prior to the scheduled time which renders the facility unsafe, Lynchburg Parks & Recreation Department reserves the right to cancel the reservation and reschedule the pool reservation at a mutually convenient date and time. If rescheduling is not possible, a refund will be issued.
- If conditions become unsafe after the user has begun a scheduled pool rental, Lynchburg Parks & Recreation will prorate the refund based on actual elapsed time rounded to the nearest half- hour. The actual elapsed time includes waiting out of the pool, a minimum of 30 minutes, before it is safe to go back in; it also includes waiting in the facility, with or without actual pool use.
- It is imperative that the users on the reservation permit provide all phone numbers where the group/ individual can be reached. Include an alternate group supervisor/ organizer name and telephone number. Most cancellation decisions due to inclement weather take place within hours of the scheduled time requiring prompt contact with the group/ individual user.

## Pool Cancellation Policy

- The Lynchburg Parks & Recreation Department's aquatic facility must be notified at least 10 business days prior to the rental in order for a refund to be given and may include a \$10 administrative fee. If a group does not show for a scheduled rental without notifying the department a refund will not be given.
